**International banks**, including CIBC First Caribbean International Bank and Royal Bank(RBC-RBTT).

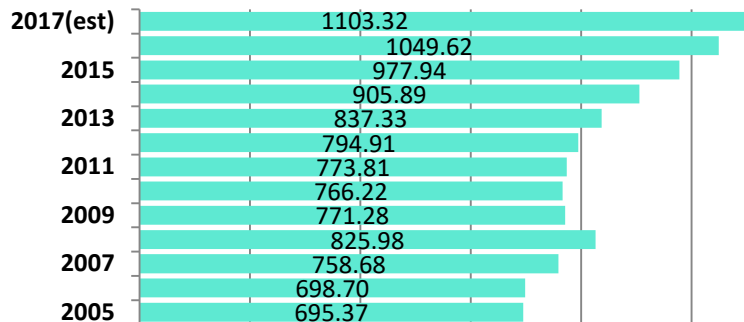

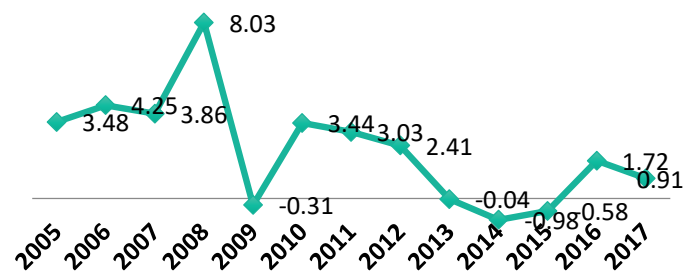

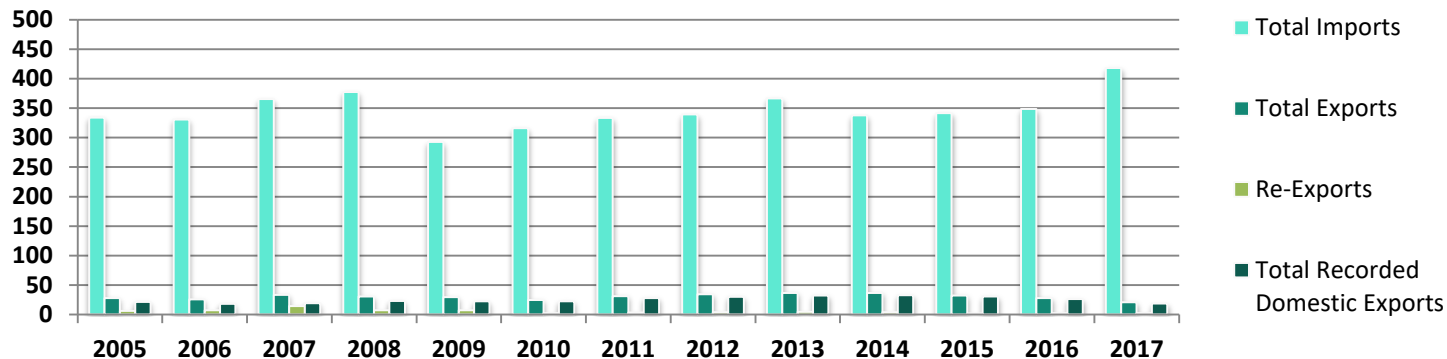
## GDP US\$ Mil



## Inflation %

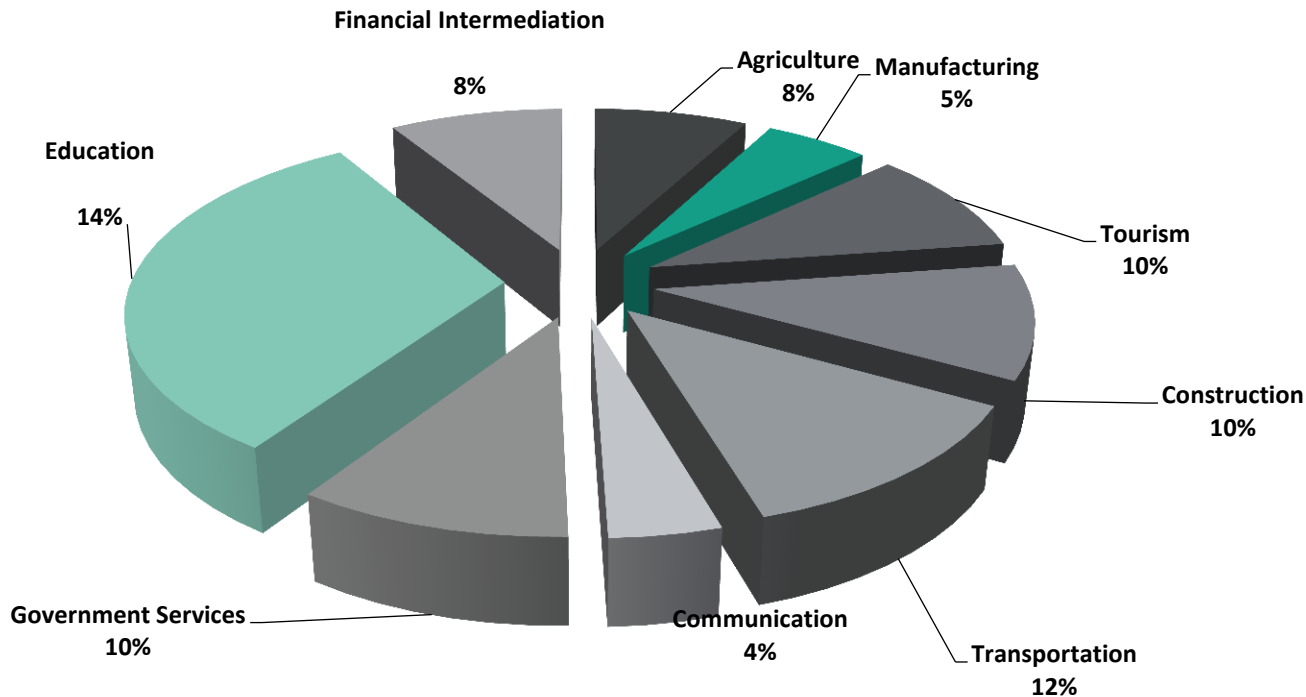


## BALANCE OF TRADE (US\$'Mil)
