




## Discover Rezekne

# Unemployment rate in Rezekne (% of economically active population)









# REZEKNE SPECIAL ECONOMIC ZONE

Taxation in Rēzekne SEZ:

Corporative Income Tax applicable on dividends **4%**\*
Immovable Property Tax **0.3-0%**\*\*

Taxation in Latvia:

Corporate Income Tax applicable on dividends 20% Immovable Property Tax 1.5%

Since 2018 corporate income tax for reinvested profit in Latvia is 0% while corporate income tax rate of 20% in Latvia and 4% in Rēzekne SEZ is applicable on dividends

80% immovable property tax is guaranteed by the law, additional 20% doscount can be granted by the local municipality

Rēzekne also provided us with a **good quantity** of readily available labour to employ and train. The location was also situated close to a high volume of forests that supply the plant with the raw material required for production.
